## **Administration**

Cheque signatories are the Headteacher, Snr Asst Headteacher, Deputy Headteacher and Business & Finance manager; any two signatures are required.

The fund is administered by Paula Shepherd; Finance Officer

The day to day management of the fund is the responsibility of the Business & Finance Manager although overall responsibility for the fund lies with the Headteacher/Governing Body.

## **Audit**

The fund has a financial year end of 31<sup>st</sup> March.

Annually, a summary of income and expenditure, and a statement of balances is prepared by the Business & Finance Manager / Finance Officer

The financial statements are audited by a third party; Working with Schools

Audited Accounts are presented to the Governing Body each year for formal approval, in accordance with the Scheme of Delegation.
